CRIME REPORTIING

OFFICIAL LANGUAGE (thanks to thenewsmanual.net)

Avoid using police lingo. Use everyday language. The <u>deceased</u> struck his <u>assailant</u> a blow to the head before receiving a fatal stab wound in the chest.

 The impossibility of a dead man (the deceased) hitting anyone was missed by the reporter, who should have rewritten the sentence:

The <u>man</u> hit his <u>attacker</u> on the head before being fatally stabbed in the chest.

ATTRIBUTION (who says so)

Only report as a fact what you know to be true. All the rest must be attributed.

Police believe (OR: say) the attacker used a large stick to beat Mr. Shazi several times before running off.

There is no need to put "police said" throughout your story, but you should include the words whenever there is any doubt (or possible dispute) at all. "Innocent till proven guilty"

Because a person has been arrested, <u>does not mean he is</u> <u>guilty.</u>

It is best not to report the name of someone suspected of a crime until formal charges have been made.

If a person is charged with a crime, you should insert the word "<u>alleged</u>" (or a similar word) whenever you are describing any aspect of the crime which may be disputed in court. This is because the defendant will probably argue that he did not do it, that it is simply an allegation.

WRONG: James Green attacked retired carpenter Ahmed Shazi at his home on Mananga Street Wednesday.

CORRECT: James Green is <u>alleged to have attacked</u> retired carpenter Ahmed Shazi at his home on Mananga Street Wednesday. If no one has been arrested and charged, you can say much more, always bearing in mind that you could be sued for defamation by anyone involved if you do not stick to the truth.

Be very careful with names:

Aquib Talib

Also, be careful of reporting names of persons involved in traffic accidents.
